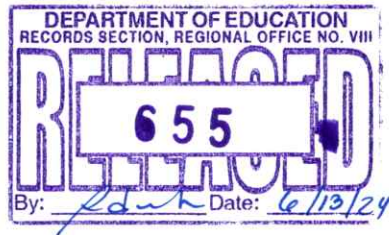

The results shall describe what the researcher found out from his/her study and the discussion shall explain the significance of those findings.
