- 1. Consistent with DepEd's (Department of Education) dedication to safeguarding the security and welfare of students and school communities, and in compliance with DepEd Order No. 37, s.2015, the Quarterly Region and Division Office Disaster Risk Reduction and Management (DRRM) Conference will be held at Ormoc City Division on June 11-14, 2024.

- 5. The transportation expenses and per diem of the participants shall be charged against their respective DPRP Fund/Maintenance and Other Operating Expenses (MOOE), subject to the existing accounting and auditing rules and regulations.
