1. 2. Primer 1, 2, and 3 shall be used as reference for the development of lesson scripts for the NRP.

3. DepEd personnel who travel or render services on days fall on summer days/holidays/weekends as part of their participation in an official activity can avail of service credits or CTO equivalent to eight (8) hours of service per day, whichever is applicable, as allowed under DepEd Order No. 67, s. 1988 and CSC Memo Circular No. 9, s. 1988.

4. For the payment of honorarium for the Non-DepEd Technical Experts, the following are considered:

- a. Non-DepEd technical experts shall receive an honorarium for the duration of the contract, following the computation as stipulated on DBM Budget Circular No. 2007-1, Guidelines on the Grant of Honoraria to Lecturers, Resource Persons, Coordinators, and Facilitators; and
- b. An honorarium is a form of compensation given as token of appreciation or reward for gratuitous services on account of one's broad and superior knowledge or expertise in a specific field for which, going by custom, tradition or propriety, no fixed price is set.

5. The Bureau of Learning Delivery has assigned specialists, namely: Mr. James Bungan and Ms. Joselita Gulapa to provide technical assistance on the development of lesson script. Hence, all SDOs are requested to submit their final schedules of the workshop on the development of lesson script assigned to them.

6. The CLMD Personnel shall also monitor the activity, and provide guidance and technical assistance to the SDOs for the smooth development, review, and finalization of the lesson scripts and to ensure complete submission of the same to the Central Office on the target schedule.

7. The Regional Director shall be responsible for approving requests from the SDO on the utilization of any excess BEC-PSF charged against BEC Funds, provided that it shall be utilized for any lesson scripts for the NRP, NMP, and CUF-related activities.

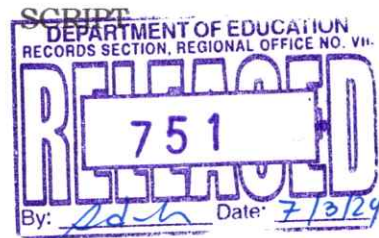

1. Pursuant to DepEd Memorandum DM-CT-2024-180, this Office, through the Curriculum and Learning Management Division (CLMD) – Learning Resources Management Section (LRMS), shall conduct a Regional Orientation on the Development of Lesson Scripts for the Implementation of the National Mathematics Program (NMP), National Reading Program (NRP), and Catch-Up Friday (CUF) on June 25-27, 2024, at the venue to be announced.
2. The activity aims to discuss:

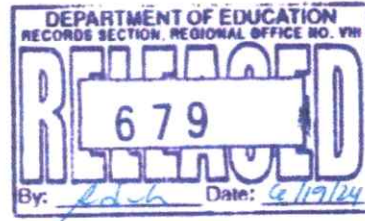

 - ii. accurate in terms of language and readability level
 - iii. aligned with the lesson scripts instructional framework
 - c. Discuss with the Development Team, including the Regional Learning Area Education Program Supervisor, Regional Learning Resource Evaluator and/or Bureau Learning Area Specialist the comments and suggestions, and agree through a consensus on the comments and revisions to be made.
 - d. Submit on time the required output as agreed with the Development Team and Management Team.
 - e. Review the revised lesson scripts for the NRP, NMP and CUFs based on the given comments and suggestions
 - f. Sign off the pages of the final lesson scripts for the NRP, NMP and CUFs.
 - g. Non-DepEd technical experts shall NOT be part of the Development Team who shall write lesson scripts.
 - h. The contract duration for the Non-DepEd technical experts is from the Development Phase to the Finalization Phase of the lesson scripts for the NRP, NMP, and CUFs.
