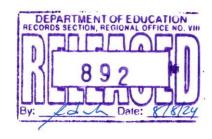

- d. Open Forum and Consultation; and
- e. Presentation of Awards.

2.0 In regard to the agreement last Midyear APR Consultation on the award for "Best APR Presentation" the following shall be the criteria for the presentation and its equivalent percentage:

#### a. Content Relevance, Clarity and Organization (50%):

- The content covers all the relevant information.
- It must address the key points or objectives of the presentation.
- The ideas/information are presented in a clear and organized manner.
- There is a logical flow of information following the prescribed sequence of presentation (i. e. physical, financial, income, refer to attached format/template).

#### b. Quality of Visuals (20%):

- The images, charts, and graphs are clear and relevant.
- The visuals enhance the understanding of the content.
- The presentation has a visually appealing design.
- The fonts, colors, images, and animations, if any are used effectively.

### c. Delivery/Presentation Skills & Audience Connection (20%):

- The presenter effectively communicates the information.
- The presenter is confident and engaging.
- The presenter connects with the audience.

#### d. Time Management (10%):

- The presenter stays within the allotted time (10 minutes).
- The pacing is appropriate for the content.
- 3.0 Moreover, as prescribed under Section 4.3.3 of CL No. 2018-13, the following documents must be submitted to DBM prior to the scheduled APR, to wit:
  - a. Agency Performance Review Report (APRR);
    - i. Executive Summary (for reports more than 5 pages)
    - ii. Objectives: areas/subject for review
    - iii. Background
      - Program/activity/project (PAP)
      - Targets for the review period
      - Valid obligational authorities for the period chargeable against all appropriation sources

#### iv. Summary of Findings

- Description of agency performance
- Explanation for deviation from targets, if any
- v. Overall agency Comments/Recommendations
  - Corrective measures for deviations, if any
  - Proposed modification in organization, staffing, systems and procedures, management, refocusing of functions, reorganization, monitoring, etc.

- Unified Reporting System (URS)-Generated Budget Financial Accountability Reports (BFARs) as of June 30, 2024; and
- c. Other information relative to the agency's performance.

We would appreciate receiving the reports no later than August 12, 2024 (Monday).
