## DEPLOYMENT OF THE REGIONAL FIELD TECHNICAL ASSISTANCE COMPOSITE TEAMS (RFTACT) TO SCHOOLS DIVISIONS

To: Schools Division Superintendents Regional Division Chiefs All Others Concerned

- 1. To sustain the strict Implementation of the Deployment of Regional Field Technical Assistance Composite Teams (RFTACT) with the ultimate goal of continuously improving instructional leadership and management, this Office, through the Field Technical Assistance Division (FTAD), informs the field of the Deployment of the Regional Field Technical Assistance Composite Teams (RFTACT) to Schools Divisions for CY 2024.
- 2. The activity aims to:
  - a. gather the technical assistance interventions provided by the Division Field Technical Assistance Composite Teams (DFTACT) to the identified schools and CLCs needing immediate and substantive assistance;
  - conduct focus group discussions with the DFTACT to thresh out priority issues, needs, and challenges relative to schools' performance and operations;
  - c. provide technical support on how to restrategize assistance and refocus resources to schools and CLCs with the utmost needs; and
  - d. elicit effective practices of the DFTACT's TA provision and analysis of interventions that improved the identified schools' and CLCs' performance;
- 3. The 1<sup>st</sup> and 3<sup>rd</sup> quarter deployments shall be conducted virtually/online while the 2<sup>nd</sup> and 4<sup>th</sup> shall be onsite/offline. Attached is the indicative schedule of the RFTACT deployment.
- 4. The School Governance Operations Division (SGOD) shall lead the activity and the consolidation of the DFTACT's TA Reports which shall be submitted five (5) working days before the RFTACT deployment and reported during the activity.
- 5. The RFTAC Teams shall submit to FTAD a TA Report right after or three (3) working days after the activity.
- Travel and other incidental expenses incurred of the RFTACT shall be charged against each respective Regional Functional Division Fund while the DFTACT's


