
The implementing guidelines on the Senior High School (SHS) Assessment and Certification Support Program, in accordance with the provisions outlined in the JOINT MEMORANDUM CIRCULAR (JMC) Series of 2024, have been established to guarantee the high-quality assessment and certification of Senior High Schools (SHSs) following the Technical Vocational Livelihood (TVL) Track. As stated in section VII on the Assessment of SHS-TVL learners, DepEd shall provide TESDA the list of and number of SHS-TVL learners, as well as the qualifications for competency assessment likewise in the issued TESDA Circular no. 45, s. 2024, section V (c) on the conduct of competency assessment DepEd Schools Division Superintendent (SDS), through the Education Program Supervisor (EPS) in-charge of the SHS-TVL, shall submit/endorse the list of SHS learners with the accomplished Assessment Application Form and Self-Assessment Guide (SAG) to the respective TESDA Provincial/District Office (PO/DO).


