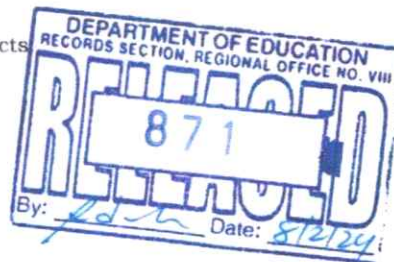

REGIONAL ECHO TRAINING ON UNIVERSAL PREVENTION CURRICULUM (UPC) FOR SUBSTANCE USE

To: Schools Division Superintendents
 CID Chief

1. This Office, through the Education Support Services Division – School Health and Nutrition Unit (ESSD-SHNU), shall conduct the Regional Echo Training on Universal Prevention Curriculum 1 on September 22-24, 2024 and Regional Echo Training on Universal Prevention Curriculum 5 on October 13-17, 2024. The venue will be announced later through a separate issuance.
2. The activity aims to:
 - a. train the prevention professional, working in a range of settings to reach all learners with research-based strategies;
 - b. provide extensive knowledge of Drug Prevention; and
 - c. be effective evidence-based prevention intervention on substance use & abuse.
3. The participants to this activity are the Division Medical Officer, Division NDEP Coordinator, Division EPS on MAPEH, 1 Division Nurse, and 1 Guidance Counselor or Designate Guidance Counselor. No substitution on this training for UPC 1 and 5.
4. Expenses incurred relative to the conduct of this activity such as board and lodging of participants shall be charged against downloaded funds while the participants traveling expenses shall be charged to their local MOOE, subject to usual accounting and auditing rules and regulations.
