EVALUATION OF IMPLEMENTATION OF BUREAU OF LEARNER SUPPORT SERVICES (BLSS) PROGRAMS, PROJECTS, AND ACTIVITIES (PPA)

1. This Office, through the Education Support Services Division-School Health and Nutrition Unit (ESSD-SHNU), shall conduct an Evaluation of Implementation of BLSS Programs, Projects, and Activities on November 21-22, 2024. The venue will be announced on a later date.
2. The objectives of this activity are as follows:
 - a. discuss the M&E core processes, craft a comprehensive and actionable M&E plan, and introduce a harmonized M&E tool to enhance project effectiveness;
 - b. determine the status of PPAs including fund utilization and accomplishments at the field offices and schools;
 - c. identify and analyze issues and challenges in program implementation;
 - d. determine the effectiveness of policies and guidelines on program delivery, institutional arrangements, fund allocation and utilization, and implementation mechanisms on the ground; and
 - e. recommend action points for improvement and harmonization of PPA implementation.
