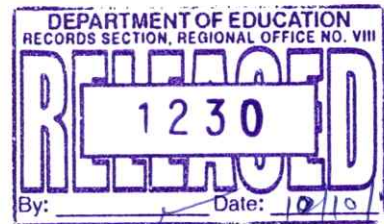

6. For immediate dissemination and compliance of this Memorandum are desired.

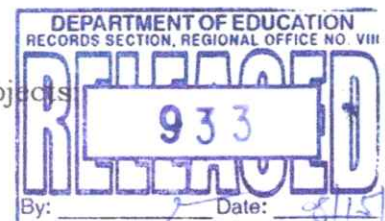
