

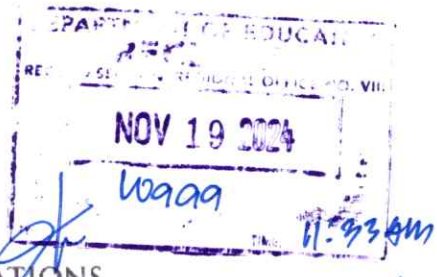

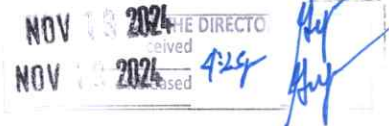

This Office, through the Learner Rights and Protection Office, spearheaded the Development of the Learning Action Cell (LAC) Session Guides for Learners with Disabilities (LWDs).

As a background, the Learner Rights and Protection Office (LRPO) conducted the *Consultation and Development of Session Guides for Learners with Disabilities: Protecting, Empowering, and Supporting the Rights of Learners with Disabilities* last March 20-22, 2024; followed by the *Writershop and Refinement* held last June 18-21 with the aim of strengthening the institutionalization of the rights of our learners with disabilities (LWD). LRPO, through the identified writers, shall be polishing the developed LAC session guides in assistance with our invited resource speakers and representatives from the National Educator's Academy of the Philippines (NEAP), based on the results of the field testing conducted in their respective schools.
