2. After the meeting, an ocular inspection of the playing venues will be conducted with the Tournament Directors on their respective events to ensure readiness for the EVRAA activities.

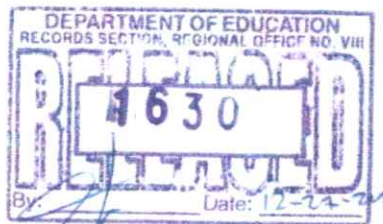
