SUBJECT : 68th ANNUAL NATIONAL COUNCIL MEETING (ANCM)

1. Pursuant to the provisions of Republic Act No. 7278 and the National By-laws of the Boy Scouts of the Philippines, we are pleased to announce the conduct of the **68th ANNUAL NATIONAL COUNCIL MEETING (ANCM)** on **26-28 February 2025** at the **Legazpi City Convention Center, Legazpi City**, hosted by the Mayon and Legazpi City Councils.
2. The conference details are as follows:

Purpose: As provided in Section 1, Article V of the BSP National By-laws, the National Council shall be convened annually to:

- Receive reports of the National President and the National Treasurer
- Elect four (4) regular members of the National Executive Board
- Ratify any proposed amendments to the BSP By-laws (if any)
- Conduct the National Court of Honor and other awarding ceremonies
- Discuss other business as may properly come before the meeting

Participation: The official delegates of the conference are the following:

- National Executive Board Members
- Regional Chairpersons and Regional Scout Commissioners
- Local Council Chairpersons and Local Council Scout Commissioners
- Local Council Executive Board (LCEB) Officers and Members
- Council Scout Executives/Officers-In-Charge (observer)
- Other regional and local council officers who wish to attend the conference may do so **as observers**. They shall have **no right to vote**.

Awarding Ceremonies: The awarding ceremonies include the following:

- The Tribute to Outstanding Scoutmasters
- The Most Outstanding Regional and Council Scout Commissioners
- The Most Outstanding Regional and Council Chairpersons
- The Lorillard Spencer Trophy Award

Election of Regular Members:

- a. Each Local Council shall be entitled to **four (4) votes only** but will be entitled to **one (1) additional vote for every ten thousand (10,000) of its Membership as of December 2024**. The additional vote(s) shall be cast only by the Head of Delegation.
- b. Participating Council Scout Executives shall be allowed to vote on behalf of the council's voting delegates provided that **he/she is the only official delegate from his/her Local Council and that a Local Council Executive Board Resolution has been submitted to the BSP National Office c/o Field Operations Division, BSP, not later than December 31, 2024**.

Registration/Conference Fee:

- a. Attendance and participation for the Local Council's and Regional Scout Committee Key Three Officials (Regional/Council Chairpersons, Regional/Council Scout Commissioners, and Council Scout Executives/Officers-In-Charge) is **FREE OF CHARGE** but not transferable.
- b. For other members of the Local Council Executive Board and Observers, each shall pay a conference fee amounting to **Six Thousand Pesos (Php6,000.00)** to cover souvenir items, supplies, and meals from the afternoon snack of 26 February 2025 up to Lunch of 28 February 2025. The conference fee **DOES NOT cover Breakfast** since they are usually included in the hotel's accommodation.
- c. Payment should be made through the Land Bank of the Philippines account with the following details:
