- Executive Order No. 325, s. 1996 mandates the Regional Development Councils (RDCs) to review and endorse to the national government the annual and multi-year investment programs and annual budgets of agency regional offices (AROs) and state universities and colleges (SUCs).
- 2. Pursuant to this, this Council approved and adopted the RDC VIII Public Investment Management (PIM) Guidelines to prescribe a general process on the preparation, submission, review, and monitoring of priority programs, projects, and activities (PPAs) in the region. Said guidelines shall strengthen the national, regional and local linkage of development priorities, investment programs, and budgets and accord higher priority to implementation-ready PPAs in the region.
- 3. This Council will also transition from the RDC VIII Budget Review Drive v. 2.0 to the RDC VIII Investment Management System (IMS), an online portal for PPA submission and monitoring, and the multi-sectoral, multi-stakeholder, and multi-dimensional technical reviews of annual budget proposals for the region.
- In view of the above, may we invite you to the Orientation on the RDC VIII PIMS Guidelines and Launching of the RDC VIII IMS on 3 February 2025, 09:00 AM - 5:00 PM at the Felipina Hall, NEDA VIII and online via Zoom. The session will also provide a walkthrough of the RDC VIII Investment Management System to guide the agencies and SUCs in the encoding and submission of your FY 2026 budget proposals for Council review and endorsement. Venue will be at the Felipina Hall, NEDA VIII, Palo, Leyte. The remaining participants per agency are requested to join online via Zoom.

We request the Department of Public Works and Highways (DPWH) VIII and the Department of Education (DepEd) VIII to extend the same invitation to and ensure the **online participation** of the foregoing officials/staff from all District Engineering Offices (DEOs) and Schools Division Offices (SDOs) in the region, respectively.
