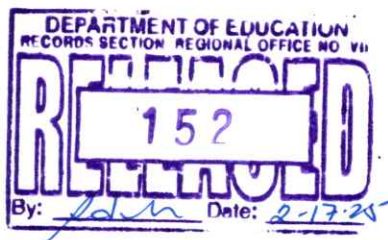

With the advent of technology, GSIS will now shift to digital platform and for this purpose, we advise you to inform GSIS Members in your office to transact more conveniently with the GSIS through **GSIS Touch -- a 24/7 mobile application** that functions like a virtual frontline.

GSIS Touch or GTOUCH, that can be downloaded using their smartphones since the app now recognizes facial image. Hereunder, the following programs available in GTOUCH, namely:

1. VIEWING OF MEMBERSHIP PROFILE, SERVICE RECORDS, LOAN & PENSION RECORDS.
2. KEEP TRACK OF PREMIUM REMITTANCES AND LOAN PAYMENTS-Loan Balance.
3. APPLY FOR LOAN
4. GET TENTATIVE COMPUTATION FOR RETIREMENT/SEPARATION BENEFIT and CSV.
5. APIR or Annual Personal Information Revalidation for both Old Age and Survivorship Pensioners.
