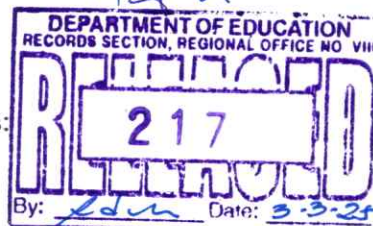

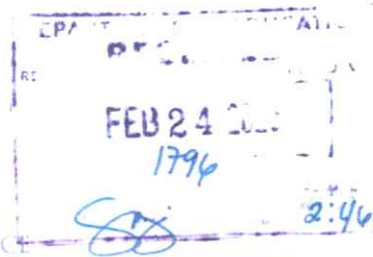

Abstract The purpose of this study was to determine the effect of a 12-week, low-intensity, low-impact, and low-volume exercise program on the physical fitness of sedentary, middle-aged women. The program was designed to be a safe and effective means of increasing physical activity for sedentary women. The program consisted of three sessions per week, each lasting 30 minutes. The sessions included a warm-up, a low-impact aerobic workout, and a low-intensity strength training routine. The program was evaluated using a variety of physical fitness measures, including heart rate, blood pressure, and body composition. The results of the study showed that the program had a positive effect on physical fitness, with participants showing improvements in heart rate, blood pressure, and body composition. The program was well-tolerated and was found to be a safe and effective means of increasing physical activity for sedentary women.
