
- 1. Please be informed that full implementation of payroll processing in the **Division** of **Eastern Samar** is hereby granted effective **April 2025**.

DECONCENTRATION OF PAYROLL PROCESSING TO THE SCHOOLS DIVISION OF EASTERN SAMAR

- 1. This is to announce the initial deconcentration of the Payroll Processing to the Schools Division of Eastern Samar effective April 2025. The SDO Eastern Samar shall pilot test its own Division Integrated Information System in its implementation of the payroll system.
- 2. To ensure a seamless transition from the Regional Office to SDO Eastern Samar, there shall be a parallel printing of all payroll-related documents for the next 3 to 6 months until a successful operation of the system is fully determined.
- 3. The Payroll-In-Charge of SDO Eastern Samar shall provide the Head of the Payroll Service of the RO a monthly report to apprise the Office of its status and determine the technical assistance needed by the SDO.
- 4. Anent thereto, the Schools Division Superintendent shall ensure the timely release of salaries and other benefits of DepEd personnel within his jurisdiction and shall take responsibility in the processing of remittances of both Government Financial Institutions (GFI) and Private Lending Institutions (PLIs).

5. Immediate dissemination of and compliance with this Memorandum are desired.
