In case of failure on the part of the aforementioned school to observe and maintain any of the required standards of DepEd affecting the course herein approved, the authority hereby granted may be revoked or cancelled, and the records of the students who have actually attended the said course may be taken over and kept in the files of DepEd, and the guaranty bond submitted by the said school is declared forfeited in accordance with the provisions of Section 8 of Republic Act No. 2706.

It is stipulated, moreover, that the recognition hereby granted does not extend to any branch and/or annex campus of the said school, whether located in the same barangay, municipality or city, or in other barangays, municipalities or cities, nor to any other course, grade, or curriculum year. Failure to operate the school for at least one (1) year is deemed to be automatically cancelled, pursuant to DepEd Order No. 88, s. 2010.

The foregoing recognition supersedes and cancels all previous records of Government approval affecting ourse or separate parts of the course herein recognized.
