LEARNER RIGHTS AND PROTECTION (LRP) DESK IN THE 2025 NATIONAL SCHOOLS PRESS CONFERENCE (NSPC), NATIONAL FESTIVAL OF TALENTS (NFOT) AND PALARONG PAMBANSA

To: Schools Division Superintendents

All Others Concerned

- 1. In compliance with DepEd Order No. 66, s. 2017 (Implementing Guidelines on the Conduct of Off-Campus Activities) and DM-OUOPS-2024-05-07998 (Supplemental Guidelines for the Implementation of DepEd Order No. 40, s. 2012 DepEd Child Protection Policy), this Office, through the Education Support Services Division (ESSD), shall establish Learner Rights and Protection Desks in the billeting quarters of the Regional Delegations during the 2025 National Schools Press Conference (NSPC), National Festival of Talents (NFOT), and Palarong Pambansa.
- 2. The Regional LRP Desk Committee shall undertake the following responsibilities:
 - a. Draft and orient stakeholders on safeguarding protocols (e.g., Technical Officials, Coaches, Chaperones, Learners).
 - b. Verify submission of all parental consent forms and necessary documentation.
 - c. Establish and maintain functional LRP Desks in all billeting quarters.
 - d. Facilitate immediate response mechanisms: incident recognition, recording, reporting, referral.
 - e. Provide on-site Psychological First Aid (PFA) and crisis counseling.
 - f. Conduct regular "Kamustahan" wellness check-ins.
 - g. Organize recreational and wellness activities.
 - h. Liaise with Local Government Units (LGUs) and other concerned agencies for appropriate referral and support services.
