AND ALTERNATIVE LEARNING SYSTEM (ALS)
FOR THE SCHOOL YEAR

1. This Office, through the Curriculum and Learning Management Division (CLMD), requires the Schools Division Offices to submit the list of schools for the scaling and implementation of the Khan Academy Program (KAP) in Region VIII for Mathematics, Science, and ALS for the SY 2025 – 2026 on or before **May 13, 2025** to **clmd.region8@deped.gov.ph** and through a shared online sheet accessible only using the DepEd MS accounts.
2. The Schools Division Superintendent shall engage the Chiefs of the Curriculum Implementation Division (CID) and the School Governance and Operations Division (SGOD) to plan, organize, monitor, and lead in the schools' implementation of the KAP. The Division shall consolidate and submit the list of KAP existing and new schools, with the required data-information.
3. The existing school-implementers of the Khan Academy Program shall submit the following information for its continued and/or scaled up implementation:
 - a) Number of implementing classes/sections across grade levels;
 - b) Course or learning area: Mathematics and/or Science;
 - c) Number of Teachers who will conduct the KAP-based class(es);
 - d) Number of Infrastructure (devices and internet); and
 - e) Average Number of Laboratory Time committed for Khan Academy implementation per week.
4. The new school implementers must:
 - a) meet the following requirements
 - a. Stable internet connectivity (speed of at least 100 mbps);
 - b. 1:1 device to learner ratio in the computer lab/room;
 - c. Eager teachers and school head; and

- d. Commitment to at least 1 Math and/or Science period of active Khan Academy time per week at school;
- b) submit the following data-information:
 - a. Number of target implementing classes/sections across grade levels;
 - b. Course or learning area: Mathematics and/or Science;
 - c. Number of Teachers who will conduct the KAP-based class(es);
 - d. Number of Infrastructure available;
 - e. Average Number of Learners per Section; and
 - f. Internet Connection Bandwidth (mbps).
