WHEREAS, the DepEd Regional Office No. VIII advertised the Invitation to Bid for the **PROCUREMENT FOR LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE CONDUCT OF 2025 QUARTER 2-4 RMEA SYSTEM IMPLEMENTATION** posted in the PhilGEPS, DepEd RO8 Procurement Websites and in the BAC Bulletin Board in the DepEd Regional Office VIII for seven (7) calendar days;

WHEREAS, pursuant to Section 10, Rule IV of the IRR of R.A. 9184, a Pre-Bid Conference was conducted on June 10, 2025 by the BAC for the above-mentioned project with Php 1,414,800.00 as Approved Budget for the Contract (ABC);

WHEREAS, during the pre-bidding conference, the members of the Bids and Awards Committee noted the provision of 3-5 items for lunch and 2 items for dessert in the approved menu and the inclusion of Breakfast and Accommodation of 8 RO Personnel which was already the subject of COA findings that RO Personnel are only allowed for Lunch and 2 snacks but no accommodation during the previous RMEA;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE AS HEREBY RESOLVED:

- 1) To declare a **cancellation of bidding** for the; **PROCUREMENT FOR LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE CONDUCT OF 2025 QUARTER 2-4 RMEA SYSTEM IMPLEMENTATION** for the reason stated above;
- 2) To recommend for approval to the Regional Director as the Head of the Procuring Entity (HoPE) the foregoing declaration.
