



REGIONAL MEMORANDUM

**IMPLEMENTATION OF AN ALTERNATIVE LEARNING SYSTEM (ALS)
PILOT ENUMERATION PROJECT IN MUNICIPALITIES WITH
HIGH INCIDENCE OF DROPOUT, OUT-OF-SCHOOL
YOUTH, ADULTS, AND CHILDREN IN
SPECIAL CIRCUMSTANCES**

1. In order to provide a basis for the regionwide advocacy and tracking of ALS learners while ensuring that no one is left behind in basic education, and with the funding support per DepEd Memorandum ATC-2025-CO-00033, dated January 15, 2025, this Office hereby requires the concerned divisions to send their respective participants, listed hereunder, to the series of activities relative to the **Implementation of an Alternative Learning System (ALS) Pilot Enumeration Project in Municipalities with High Incidence of Dropout, Out-of-School Youth, Adults, and Children in Special Circumstances** on the dates and venues to be announced in a separate issuance, to wit:

- a) Regional ALS Focal Person, DepEd Regional Office VIII;
- b) Division ALS Focal Person, Leyte Division;
- c) Education Program Specialist II for ALS, Leyte Division;
- d) ALS Teachers assigned in Bato, Leyte;
- e) ALS Teachers at Bato School of Fisheries;
- f) Division ALS Focal Person, Southern Leyte Division;
- g) Education Program Specialist II for ALS, Southern Leyte Div.;
- h) ALS Teachers assigned in Malitbog, Southern Leyte;
- i) ALS Teachers at Malitbog National High School; and
- j) Members of Technical Working Committees (to announced later).

2. The Regional ALS Focal Person shall coordinate with the above-mentioned Division Offices through their respective ALS Focal Persons and shall conduct onsite visits to the schools to facilitate the necessary arrangements effective immediately until the official commencement of the project.

3. Once confirmed as beneficial and appropriate, the schools shall host the scheduled activities, with ALS support funds to be released by the Regional Office at the soonest possible time.
4. The hiring, honorarium payment, and travel allowance of the enumerators shall be governed by the existing policies applicable to contract of service employees, and shall be closely supervised by the concerned Division Offices. Priority in the recruitment shall be given to aspirants listed in the Registry of Qualified Applicants (RQA) for teaching positions.
5. Furthermore, the designated Technical Working Committees shall be responsible for monitoring the overall progress and implementation of the project.
6. Participants' travel and other expenses related to this activity shall be charged against the **downloaded ALS Funds** at their respective offices, subject to the usual accounting and auditing rules and regulations. The reimbursement of the aforementioned expenses shall only be granted upon submission of the complete requirements.
