OFFICIAL REGIONAL DELEGATION TO THE 2025 NATIONAL SCHOOLS PRESS CONFERENCE

To: Schools Division Superintendents

Division Campus Journalism Coordinators

All Others Concerned

- 1. This Office, through the Curriculum and Learning Management Division (CLMD), announces the herein attached list of **194 participants** as the official regional delegation of DepEd Region VIII to the **2025 National Schools Press Conference (NSPC)** which will be held on May 19-23, 2025 in Vigan City, Ilocos Sur.
- 2. The official regional delegation shall include the Rank 1 RSPC Winners in the Individual Contests and Group Contests and their coaches, Most Outstanding Campus Journalists and their advisers, Most Outstanding School Paper Advisers, Regional Officials, Division Campus Journalism Supervisors, Eastern Visayas Association of School Paper Advisers' Association (EVASPA), Inc. Officers, Learner's Rights Protection (LRP) Officer, and some observers assigned in concurrent sessions or the mobile journalism exhibition whose names are identified in the attached enclosure.
- 3. Participants who are not part of the official delegation such as DepEd Officials, school heads, teachers, and personnel but are taking part in an official capacity to support and monitor their respective delegation may be authorized by the Schools Division Offices to attend the NSPC and be covered in their travel using local and other applicable funds. However, they, including other participants who are attending the activity in a personal capacity, shall take care of their own travel arrangements and provisions as applicable.
- 4. Since the participation in the national event is voluntary, participants who decide not to join may be replaced. In case a student-qualifier is unable to participate, the next in rank from the same contest shall be the priority replacement. Hence, the schools divisions, through the Division Campus Journalism Supervisors, must exercise diligence in checking the willingness and readiness of their division qualifiers and notify the Regional Office in advance in case some participants cannot join so that those who are eligible to participate can still make preparation for travel.
- 5. The campus journalism supervisors of the divisions, aside from serving as delegation heads, shall be assigned a specific campus journalism category to supervise and monitor during the conduct of the NSPC. They shall ensure that contestants are guided and provided technical assistance as necessary.

- 6. To ensure smooth travel and/or admission to the contests, the participants are reminded to prepare or accomplish the following items:
 - a. School Paper Advisers/Division Officials identified in the NSPC Memorandum
 - Division endorsement which includes the name of the SPA in the official list of division participants
 - Letter request and official endorsement (for substitutes or replacements who are not mentioned in the first/original division endorsement)
 - Travel Authority signed by the Schools Division Superintendent
 - Valid office/school ID
 - Medical certificate (for those with medical condition requiring clearance for travel)
 - b. Campus Journalists
 - Division endorsement which includes the name of the campus journalist in the official list of division participants
 - Letter request and official endorsement (for substitutes or replacements who are not mentioned in the first/original division endorsement)
 - Travel Authority signed by the Schools Division Superintendent
 - Parental Consent and Waiver Form
 - Alternative Accommodation Agreement with a notarized waiver (for those who will prefer to stay outside the official billeting schools)
 - · Valid school ID
 - Medical certificate (for those with medical condition requiring clearance for travel)
 - Copy of current school paper (print or digital/electronic format)
 - Plain white shirt (for contestants in the group category)
- 7. Moreover, the Division Campus Journalism Supervisors are tasked to accomplish a Travel Itinerary Tracking Template (See Enclosure D) indicating whereabouts on their delegation's date of departure, origin, expected arrival, etc.
- 8. In terms of food and accommodation, the official participants shall be provided billeting quarters and free meals by the Host Region/Division at the **Banaoang Elementary School** from May 18 (lunch) until May 23 (morning snacks).
- 9. In view of the summer weather and the high heat index, the participants are advised to make necessary precautions such as bringing portable personal fans, water bottles, sunglasses, hats, medicine, and protective or suitable gear.
- 10. Travel expenses of student contestants/participants shall be subsidized through the Development and Promotion of Campus Journalism Program (DPCJ) Program Support Fund embedded in SARO No. OSEC-8-25-02127 dated April 7, 2025 which was downloaded to the concerned divisions while travel and incidental expenses of teachers, school officials, supervisors, and other participants shall be charged against their respective local funds such as the MOOE, Special Education Fund (SEF), Campus Journalism Fund, EVASPA Funds, or other applicable sources, subject to the existing accounting rules and regulations. In case the subsidy for travel

expenses of students is not enough, the sources of funds above may also be utilized to augment the budget for travel or be claimed as source of travel reimbursement.

- 11. As stipulated in DepEd Memorandum No. 39, s. 2025, teacher-coaches who participate in entire duration of the 2025 NSPC shall be granted 7.5 days of Vacation Service Credits (VSC). For those who are unable to complete the required period, each hour of their rendered service shall be equivalent to 1.5 hours of VSC.
- 12. To address concerns about the activity preparations and other arrangements, a pre-departure virtual meeting of both the NSPC and NFOT regional delegations shall be held on May 13, 2025, 3:00 P.M., via Google Meet (https://meet.google.com/eyd-psyj-hap).
- 13. For more details as to contest guidelines and other relevant information about the NSPC, refer to the above-mentioned issuance.
- 14. Immediate dissemination of and compliance with this Memorandum are desired.
