REMINDER ON THE REQUIREMENTS OF THE APPLICATION FOR SCHOOL FEES OF PRIVATE SCHOOLS

To: Schools Division Superintendents Regional Office Division Chiefs All Others Concerned

1. In adherence to the standard guidelines on school fees, this Office, through the Quality Assurance Division (QAD) informs the field on the Requirements of the Application for School Fees of Private Schools, as follows:
