**DOWNLOADING OF FISCAL YEAR 2025 CONTINUING AND CURRENT
ALTERNATIVE LEARNING SYSTEM (ALS) FUNDS TO SUPPORT
TRAVEL AND ALS PROGRAM IMPLEMENTATION IN THE
SCHOOLS DIVISION OFFICES AND SCHOOLS**

To: Schools Division Superintendents
Regional Division Chiefs
All Others Concerned

1. To provide funds for the travel reimbursement of participants to various Bureau of Alternative Education (BAE) and Regional Office initiated activities as of May 9, 2025, and to give support to select ALS Senior High Schools (SHS) on the Total Mapping and Assessment Project pilot implementation, this Office, through the Curriculum and Learning Management Division (CLMD) and Finance Division (FD), shall download **One Million Three Hundred Forty-Five Thousand Three Hundred Twenty-Three Pesos and 30/100 (P1,345,323.30)** from the **OSEC-8-24-3479, FY 2025 GAAAO - Annex 1**, and **OSEC-8-25-00099**, through a Sub-ARO to the division offices and select ALS SHS pilots based on the breakdown and corresponding purposes presented in the enclosure.
2. The Schools Division Superintendents, through the respective Division ALS focal Persons, shall submit financial reports on the utilization of the downloaded funds on or before July 31, 2025 to **clmd.region8@deped.gov.ph cc alfredo.cafe@deped.gov.ph**.
3. There shall be a monitoring on the utilization of the downloaded funds which shall be led by the Regional ALS Focal Person and may be composed of the CLMD EPSs and a representative from the FD and Quality Assurance Division (QAD) on the third and fourth quarters of the Fiscal Year 2025 of which expenses are chargeable against the ALS Funds, subject to the usual accounting and auditing rules and regulations.
