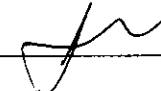

CONTRACT AGREEMENT No. 14-25

THIS AGREEMENT made the ____ day of 04 AUG 2025 between **DEPARTMENT OF EDUCATION REGIONAL OFFICE VIII**, represented by **DR. EVELYN R. FETALVERO, CESO IV**, in her capacity as the **REGIONAL DIRECTOR** of the **DEPED RO VIII**, hereinafter referred to as the "**Entity**"; and **REX BOOK STORE INC.** of **QUEZON CITY** hereinafter called "**the Supplier**" of the other part;

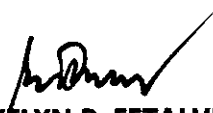

In consideration for the sum of **Philippine Pesos Five Million Seven Hundred Sixty Thousand Pesos (PhP 5,760,000.00) only** or such other sums as may be ascertained, and **REX BOOK STORE, INC.** agrees to the **PROCUREMENT OF SLRs 2024 FOR THE EIGHT (8) LIBRARY HUBS: BILIRAN, EASTERN SAMAR, LEYTE, NORTHERN SAMAR, ORMOC, SAMAR, SOUTHERN LEYTE AND TACLOBAN OF DEPED REGION VIII-LOT-1** in accordance with his/her/its Bid.
