PARTICIPANTS IN THE BOOKKEEPING AND EVENT MANAGEMENT NATIONAL CERTIFICATION LEVEL III (NC III) TRAINING AND ASSESSMENT

To: Schools Division Superintendents
All Others Concerned

- 1. In preparation for the Pilot Implementation of the Strengthened Senior High School (SHS) Program at selected schools in the region, this Office, through the Curriculum and Learning Management Division (CLMD) in collaboration with Ghrace Jhoy Technical and Vocational School, Inc. and SOS Children's Village Calbayog City, Inc., shall conduct the Bookkeeping and Event Management National Certification Level III (NC III) Training and Assessment, simultaneously on May 19 June 8, 2025 in Southern Leyte and Calbayog City.
- 2. This activity is part of the CLMD initiative called Project National Certification for Educators (Project NC4E). The goal of this project is to develop and implement a national teacher certification project that equips and recognizes educators who integrate Technical-Vocational Education and Training (TVET) into academic instruction. It aims to enhance teaching quality, promote curriculum relevance, and prepare learners for both higher education and workforce readiness in the 21st century.
- 3. The participants include teachers from the Business and Entrepreneurship cluster, specifically those teaching Basic Accounting and Introduction to Organization and Management electives, as well as teachers who have the potential to integrate bookkeeping and event management. These teachers will be responsible for producing graduates with NC III certification. The list of participants, training and assessment schedule, and the members of the Technical Working Group (TWG) are enclosed in this memorandum.
- 4. As existing Joint Delivery Voucher Program (JDVP) Partner Institutions, Ghrace Jhoy Technical and Vocational School, Inc. and SOS Children's Village Calbayog City, Inc. will provide free training for the teachers. While the assessment cost, accommodation, travel, and other incidental expenses of the participants and the members of the TWG shall be charged to their respective Local Funds / School MOOE subject to the usual government accounting and auditing rules and regulations.
- 5. The participants and the TWG are entitled to service credits based on DepEd Order No. 67, s. 1988 and CSC Memorandum Circular No. 9, s. 1988 stipulating that those who travel or render services on days that fall on holidays, weekends, and

summer breaks shall also be entitled to avail of service credits or compensatory timeoff (CTO) equivalent to eight (8) hours of service per day, whichever is available.

- 6. To facilitate the conduct of the activity, this Regional Memorandum shall serve as the Travel Order.
- 7. Immediate dissemination of and compliance with this Memorandum are desired.
