**REGIONAL TRAINING OF SPORTS CLUB FACILITATORS
ON THE TEACHING OF SPORTS-SPECIFIC SKILLS**

To: Schools Division Superintendents
Division Sports Officers
All Others Concerned

1. In line with the DepEd Memorandum OM-OUOPS-2024-10-07365, titled National Training of Sports Club Facilitators on the Teaching of Sports-Specific Skills, this Office, through the Education Support Services Division (ESSD), will conduct the Regional Training of Sports Club Facilitators on the Teaching of Sports-Specific Skills on **August 4-8, 2025** for the first batch, and **August 11-15, 2025** for the second batch. The venue of the activity will be in Baybay City and Calbayog City Division; the exact location of the venue will be announced in a separate memorandum.

2. The sports to be covered are as follows: Arnis, Dancesport, Pencak Silat, Table Tennis, Sepak Takraw, and Wushu. Each SDO is enjoined to send one (1) Head of Division delegation, preferably the Division Sports Officer, and two (2) participants per event. Participants are reminded to bring the necessary equipment. Furthermore, participants will be identified by the Division Sports Officer or the Focal Person for School Sports and are requested to submit their respective lists of participants by completing the form through the following link:

3. This activity aims to:

- To support the effective implementation of the Sports Club Program in public schools.
- To enhance facilitators' knowledge, skills, and understanding of various sports skill sets.
- To align the teaching of sports-specific skills with the performance indicators in the DepEd Sports Manual.
- To promote consistency and quality in the delivery of school-based sports programs.
- To strengthen the capacity of facilitators in guiding learners toward athletic development and values formation.

4. The participants in this training program shall be provided with meals and accommodation for four (4) days. Travelling expenses, meals, and snacks of the participants shall be charged to local funds/MOOE, subject to the usual accounting and auditing rules and regulations.
