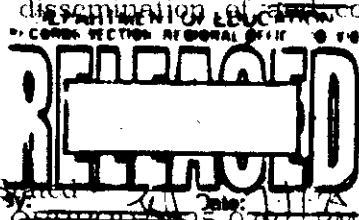
**RESCHEDULE OF THE CONDUCT OF BATCH 5 TRAINING
