

CONDUCT OF FIELD CONSULTATION FOR THE DRAFT DEPED ORDER

ON THE SCHOOL MENTAL HEALTH PROGRAM

: July 1, 2025

DepEd is committed to promoting and protecting the mental health and well-being of learners by fulfilling its mandates under **Republic Act (RA) of 11036** or the *Mental Health Act* and **RA 12080** or the *Basic Education Mental Health and Wellbeing Promotion Act*. In line with this, the Bureau of Learner Support Services – School Health Division (BLSS-SHD) has drafted the following policies:

- 1. **DepEd Order on the School Mental Health Program.** This aims to strengthen learners' resiliency and well-being by (a) promoting their mental health and well-being; (b) preventing further mental health risks; and (c) addressing their mental health concerns and conditions of through appropriate interventions.
- 2. DepEd Memorandum on the Interim Guidelines for Mental Health Crisis Response and Management (MHCRM). The MHCRM guidelines outline the steps to respond, manage, monitor, and refer cases to ensure the safety and well-being of learners during and after a crisis.

In compliance with Republic Act (RA) 12080, BLSS-SHD will conduct a consultation with guidance counselors and advocates to gather their comments on the subject policies. This consultation serves to complement the previous consultations conducted on June 5 and 19, 2025, with parents, learners, and other relevant school personnel. The consultation aims to gather valuable information, input, and recommendations from relevant offices to ensure a comprehensive, and aligned with existing mental health policies, laws and memorandums.




