Greetings!

Dengue is a persistent and constant public health concern no matter the season. Last year, Eastern Visayas reported a record high dengue epidemic with cases reaching 15,669 and 27 deaths. Currently, the Regional Epidemiology and Surveillance Unit (RESU) reported 2,292 dengue cases with 2 deaths.

To achieve our goals of reduced dengue morbidity and mortality, the DOH-EVCHD thru the National Aedes-borne Viral Disease Prevention and Control Program (NAVDP) will conduct a **Dengue Consultation Meeting with Stakeholders** on July 22-24, 2025 at **Madison Park Hotel, Tacloban City**. This aims to provide important updates to our partner stakeholders and emphasize the need for whole of government and whole of society approach for effective dengue prevention and control.

In light of this, we would like to invite 6 (six) **Medical Officers (one from each province)** to attend the said activity.

The meeting will start at 10:00 am on July 22 and will end at 12:00 pm on July 24. The DOH-EVCHD will provide the venue, meals and accommodation, while TEV and per diems will be shouldered by the sending agency.
