**DOWNLOADING OF THE PROGRAM SUPPORT FUNDS (PSF) FOR THE
ADMINISTRATION OF THE RAPID MATHEMATICS ASSESSMENT
(RMA) IN DIVISION OFFICES**

To: Schools Division Superintendents
Education Program Supervisors in Mathematics
All Others Concerned

1. Pursuant to the Joint Memorandum issued by the Curriculum and Teaching Division and the Finance Division of the DepEd Central Office dated November 18, 2024, titled "2024 Implementing Guidelines on the Program Support Fund for the Administration of the Rapid Mathematics Assessment (RMA) and the Printing of RMA Tools and Mathematics Supplementary Learning Materials," this Office, through the Curriculum and Learning Management Division (CLMD), has downloaded a total amount of **Ten Million Eight Hundred Five Thousand Five Hundred Two Pesos and Ninety-Two Centavos (P10,805,502.92)** to the Schools Division Offices (SDOs), chargeable against OSEC – 8-24-7715.

2. The funds downloaded to the Schools Division Offices (SDOs) shall be utilized for the effective administration of the Rapid Mathematics Assessment (RMA) in schools under their respective jurisdiction for School Year (SY) 2025–2026. Specifically, the allocated amount shall support the following key areas:

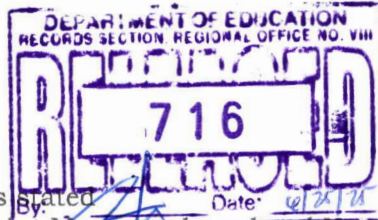
a. Intervention and Enrichment Materials: These include contextualized teaching-learning plans and learner worksheets aimed at addressing identified learning gaps and accelerating progress among learners across varying levels of performance.

b. Orientation and Training: To promote consistent and systematic administration of assessment tools, and to ensure the appropriate use of supplementary resources (i.e., intervention and enrichment materials), teachers shall receive relevant orientation and training, along with necessary instructional materials.

Furthermore, in relation to the conduct of the Regional RMA Training scheduled on June 30 to July 2, 2025, the travel and incidental expenses of division-identified participants shall likewise be charged to this fund.

3. Attached to this Regional Memorandum is Enclosure No. 1 that details the specific amount of downloaded funds to each division. All the expenses related to the allowable activities shall be subject to the existing rules and regulations of the Commission On Audit (COA).

4. Immediate dissemination of and strict compliance with this Memorandum are desired.
