**MANDATORY NATIONAL CERTIFICATION AND TRAINERS' METHODOLOGY
FOR TECHNOLOGY AND LIVELIHOOD EDUCATION (TLE), SPECIAL
PROGRAM IN TECHNICAL VOCATIONAL EDUCATION (SPTVE),
AND TECHNICAL VOCATIONAL LIVELIHOOD (TVL)
TEACHERS IN COMPLIANCE WITH THE
DEPED ORDER NO. 003, S. 2025**

To: Schools Division Superintendents
All Others Concerned

1. In reference to DepEd Order No. 003, s. 2025, titled "Guidelines on the Implementation of Quality-Assured Assessment for the National Certification of Learners in the Senior High School Technical-Vocational-Livelihood Track and Expansion of the Number of Competency Assessors", this Office, through the Curriculum and Learning Management Division (CLMD) reiterates the requirement for all teachers handling Technology and Livelihood Education (TLE), Special Program in Technical Vocational Education (SPTVE), and Technical-Vocational-Livelihood (TVL) subjects to possess the following:

- a. National Certificate Level II (NC II) in the qualification/specialization they are teaching; and
- b. Trainers Methodology Level I (TM I) as a minimum requirement for delivering competency-based instruction.

2. This directive aims to provide learners with high-quality training that meets industry standards and helps improve their chances of passing the free National Certification assessments offered through the Department of Education and Technical Education and Skills Development Authority (DepEd-TESDA) partnership.

3. All Schools Division Offices through the Education Program Supervisor (EPS) in TLE/SPTVE/TVL are directed to conduct an inventory of teachers and their corresponding NC II and TM1 certifications. The consolidated report must be submitted vial email: **cldm.region8@deped.gov.ph** on or before July 11, 2025.

4. The Division EPS shall coordinate with their respective TESDA Provincial Offices to arrange weekend schedules for specialization training and assessment of teachers who either lack NC in the qualifications they teach or have expired NCs. The SDO may also implement alternative strategies to support and facilitate teacher training and assessment.
