Subject : SUBMISSION OF REQUESTS FOR STAFFING MODIFICATION IN RELATION TO THE ISSUANCE OF DEPED-DBM JOINT CIRCULAR (JC) NO. 011, S. 2025 DATED FEBRUARY 19, 2025

- This refers to DepEd-DBM JC No. 01, s. 2025, dated February 19, 2025. Pursuant to Item 14.1 of the said Joint Circular, its effectivity shall commence 1.0 fifteen (15) calendar days following its publication in either the Official Gazette or in a newspaper of general circulation in the Philippines. Furthermore, it is stipulated therein that all applications for reclassification of teaching and school head positions received by the DBM Regional Office (RO) after the said effectivity shall be processed in accordance with the provisions of the said Joint Circular.
- Further, Item 14.2 of the aforementioned JC provides that all applications for reclassification of teaching and school head positions received by the DBM RO 2.0 prior to the effectivity of said JC shall continue to be governed by the previous policies and guidelines, as applicable.
- In line with this, and pursuant to the directive of the DBM Central Office through the Organization, Position Classification and Compensation Bureau (OPCCB), 3.0 and in consideration of the effective date of DepEd-DBM JC No. 01, s. 2025, this Office shall henceforth only accept staffing modification requests that are compliant with the provisions of said JC. Moreover, all pending staffing modification requests received by this office on or beyond June 4, 2025, which remains unacted as of this date, shall be returned to the requesting agency.

Staffing modification requests received by this Office prior to June 4, 2025, but subsequently returned to the concerned agency due to noted inconsistencies/deficiencies, may still be resubmitted to this Office not later than July 28, 2025, provided that the issues identified have been duly addressed and complied with.
