MISTER & MISS DEPED REGION VIII 2025 GUIDELINES AND MECHANICS

GENERAL GUIDELINES:

- 1. The Mister and Miss DepEd Region VIII 2025 is in the form of a contest.
- 2. The contest is exclusively for non-teaching personnel from the 13 Schools Division Offices (SDOs) and Regional Office. Each SDO and RO shall send one male and one female representative.
- 3. Contestants must be permanent or contractual employees with at least 1 year of service. Possess good moral character, no pending administrative cases, and physically and mentally fit to participate in the event.
- 4. Exposure of the pageant will be as follows:
 - A. Production Number (Office Uniform)
 - B. Sportswear
 - C. Filipiniana/Barong
 - D. Question and Answer Portion
 - E. Announcement of Winners
- 5. A panel of judges composed of external experts and internal evaluators will assess each segment. Scores from all segments will be tallied cumulatively and will utilize a rank system to determine winners.
- 6. General rehearsal of the show is at exactly 8:00 am on July 17, 2025.

Exposure Categories & Guidelines

1. Presentation of Candidates (no rating from the judges)

2. Production Number

- All candidates will perform in a group opening dance or thematic presentation.
- Attire: Office Uniform
- Judging Criteria:
 - Stage Presence 30%
 - Synchronization and Coordination 30%
 - o Neatness and Visual Appeal 20%
 - Over-all Impact 20%

3. Sportswear Competition

- Candidates will wear sports-themed outfits of their choice (e.g., gym wear, athletic uniforms, etc.) except overly revealing outfits (swimwear and trunks).
- · The segment highlights fitness, confidence, and wellness advocacy.
- Each candidate will do a short ramp walk and a 10–15 second pose to showcase their outfit and persona.
- Judging Criteria:
 - o Confidence and Personality 30%
 - o Appropriateness of Sportswear 30%
 - o Physical Fitness & Poise 20%
 - o Audience Impact 20%

4. Filipiniana Attire Competition

- Candidates will wear traditional Filipiniana attire (Barong Tagalog for males, Filipiniana for females) in Gold and Black color.
- This segment emphasizes Filipino identity, elegance, and bearing.
- This shall be followed with question-and-answer portion to assess wit and communication skills.
- Judging Criteria:
 - o Elegance and Bearing 40%
 - o Relevance and Authenticity of Attire 40%
 - o Overall Stage Presence 20%

5. Question & Answer Portion

Each candidate will be asked a random question intended to assess his/her ability to think critically, express oneself clearly, and demonstrate poise under pressure.

Coverage will be as follows:

- History of DepEd Region VIII
- Mandate of the Department of Education
- Roles and Functions of non-teaching personnel
- Major issues in the Department of Education
- Implementation of Big-Ticket Programs, Project, and Activities

Judging Criteria:

- o Content of the Answer 50%
- o Delivery and Articulation 25%
- o Confidence and Presence 25%

Announcement Of Winners

The decision of the board of judges is final and irrevocable. In case of a tie happens, the Chairman of the Board of Judges will break the tie.
