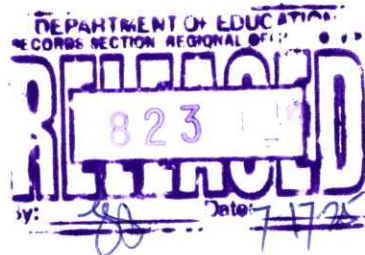

**CONDUCT OF MID-YEAR REGION AND DIVISION OFFICE DISASTER RISK
REDUCTION AND MANAGEMENT (DRRM) CONFERENCE**

1. In line with the Department of Education's (DepEd) commitment to ensuring the safety and well-being of learners and school communities, and pursuant to DepEd Order No. 37, s. 2015 or *The Comprehensive Disaster Risk Reduction and Management (DRRM) in Education Framework*, this Office informs all Division DRRM Coordinators on the conduct of the Mid-Year Region and Division Office Disaster Risk Reduction and Management (DRRM) Conference on July 22-25, 2025 at a venue which will be announced in a later memorandum.
2. The activity shall be participated by the following: three (3) representatives from the Education Support Services Division (Chief, PDO IV, and PDO II), thirteen (13) Division DRRM Coordinators, two (2) personnel from the host Divisions as part of the Technical Working Group (TWG) and two (2) personnel from DRRMS Central Office.
3. The activity aims to review and assess the implementation of DRRM PPAs at the region and division levels, discuss concerns on FY 2025 Disaster Preparedness and Response Program (DPRP) Funds, and discuss upcoming DRRM-related activities.
4. The transportation expenses and per diem of the participants shall be charged against their respective DPRP Fund/Maintenance and Other Operating Expenses (MOOE), subject to the existing accounting and auditing rules and regulations.
5. Immediate dissemination of and compliance with this Memorandum are desired.
