- 1. In view of the implementation of DBM Budget Circular No. 2024-2, s.2024 dated August 2, 2024 "Guidelines on the Payment of Communication Expenses of Certain Government Personnel" and DepEd Order No. 014, s. 2025 dated May 08, 2025 "Guidelines on the Provision and Use of Official Mobile Phones, Postpaid Lines and Prepaid Loads", this office hereby informed all concerned on the new list of personnel, amount of allowable communication expenses and updated documentary requirements.

  - d. Duly signed and noted self-certification (Annex A, DBM-BC No. 2024-2, s. 2024) (1 copy).
- 3. Attached is the list of personnel with the authorized monthly allocation.




