POSTER MAKING CONTEST**

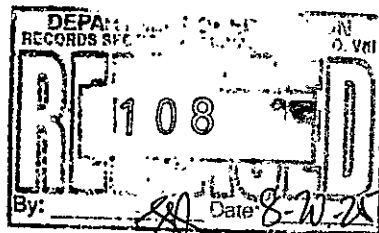

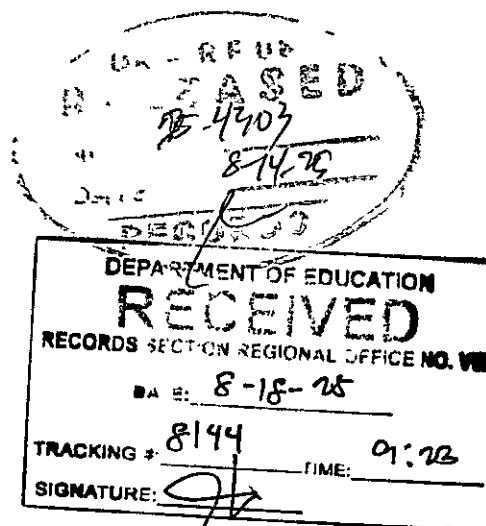

GENERAL PROVISIONS

1. The contest is open to all Grades V to VI elementary pupils enrolled in any public and DepEd-accredited private schools nationwide. Previous national winners are not eligible to join the contest.
2. Contestants are required to wear their school uniform throughout the contest both in the regional and national levels.
3. The poster should be an original creation of the contestant depicting the given theme of the contest, which will be written outside the borders of the illustration board (1-inch border on all sides), and not incorporated in the artwork. Contestants who do not follow instructions will automatically be disqualified.
4. The final theme for this year's On-the-Spot Poster Making Contest, which will revolve on the 2025 WFD theme: "Hand in Hand for Better Foods and a Better Future," will be announced during the contest.
5. The Contest Committee will provide materials for the Poster Making Contest such as Illustration board (20" x 30"), Oil pastels (24 pieces), Ruler, Pentel pen, Ball pen, Pencil, Tissue, Cotton ball, and Eraser.
6. After the contest preliminaries, the contestants will be given a maximum of three (3) hours and 30 minutes to complete their posters.
7. Judging shall immediately commence after the allotted time for the contestants. Only the Board of Judges (BOJ) Technical Working Group (TWG) and secretariat are allowed inside the contest area during the evaluation.
8. The decision of the BOJ shall be final and irrevocable. However, if the winner has been proven to commit any misconduct (i.e. plagiarism, or any form of cheating, the title and prize shall be forfeited.
9. The top awardees and other contestants shall receive cash prizes, certificates, and tokens.
10. All entries shall become the property of the DA and FAO.

REGIONAL LEVEL

The poster making contest shall be conducted on-the-spot at the regional level. (Division/ District level contest may be conducted provided that expenses to be incurred shall be shouldered by the DepEd Regional Office or their counterpart.)

1. Each contestant may be accompanied by and shall be allowed to have one (1) coach or one (1) guardian to accompany him/her to the venue. However, neither the coach or guardian are not allowed to enter or roam around the contest venue during the contest proper.
2. The regional winner shall be the official contestant and must be endorsed by the Regional On-the-Spot Poster Making Contest Committee to the National Level.
3. The Regional Winner shall be allowed to have one (1) guardian or one coach to accompany him/her during the National On-the-Spot Poster Making Contest.

a. Originality	-	30%
b. Creativity	-	30%
c. Visual Impact	-	20%
d. Relevance to the Theme	-	20%
