2. The post-qualification process shall be conducted comprehensively to ensure that all learning tools and equipment (LTE) for SHS TVL programs are thoroughly inspected. Schools Division Offices (SDOs) and schools are encouraged to support this initiative by allowing the active participation of the Special Technical Working Group (TWG) in this critical activity.

3. The Special TWG shall oversee all inspection activities to ensure that the procured tools and equipment meet the prescribed standards and specifications, thereby enhancing the effective delivery of TVL instruction. They shall likewise commit to being available on all scheduled inspection dates— as announced by the regional office— to conduct the checking of learning tools and equipment in coordination with the Division Education Program Supervisor for TVL.

4. Travel expenses shall be charged against local funds, School MOOE, or other available funds subject to usual government accounting and auditing rules and regulations.

5. Immediate dissemination of and compliance with this Memorandum are desired.
