1. In line with DepEd Memorandum No. 69, series of 2025, the Human Resource Development Division (HRDD) announces that the conduct of the FY 2025 National Assessment for School Heads (NASH) in Region VIII will be held in two batches as follows:

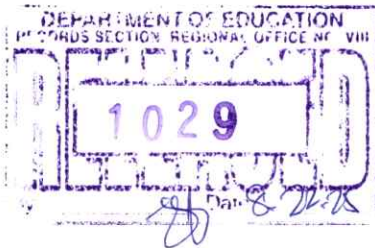
5. A set of orientations shall be conducted before the mock and actual examinations, with the schedules as follows:

6. No examination fee shall be collected from the NASH examinees. To support the effective conduct of the FY2025 NASH at the designated assessment sites, a program support fund shall be downloaded to the concerned Schools and Schools Division Offices (SDOs) to cover the necessary operational expenses.

7. HRDD shall facilitate the procurement of board and lodging for participants attending the FY2025 NASH Orientation and Post-Conference. Additionally, expenses related to the provision of uniform T-shirts, supplies/materials, communication, and travel of NASH administration personnel shall be charged against the downloaded HRTD fund (OSEC-8-25-03945), subject to the usual accounting and auditing rules and regulations.
