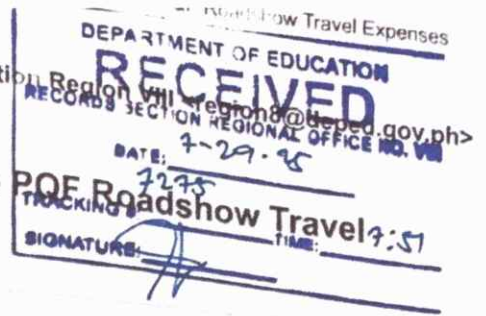

Greetings from the PQF Council Secretariat!

The Philippine Qualifications Framework National Coordinating Council (PQF-NCC), through its Permanent Secretariat under the Department of Education, shall be conducting the **2025 PQF Roadshow** to address the prevailing lack of awareness, information, and understanding of the PQF across the education, training, and labor sectors and their stakeholders.

During the 10th Pre-Management Committee Meeting held on May 30, 2025, in Laoag City, Ilocos Norte, the PQF Council Secretariat through its Strategic Advisor, Rafaelita M. Aldaba, former DTI Undersecretary presented this plan to the DepEd Executive Committee and Management Committee members.

In this regard, the Secretariat shall download project funds to your Office, amounting to *two hundred twenty-nine thousand and five hundred pesos only* (PHP 229,500.00) for the 27 participants – 12 from DepEd and 15 from non-DepEd to cover the **travel expenses** of designated DepEd and non-DepEd participants.
