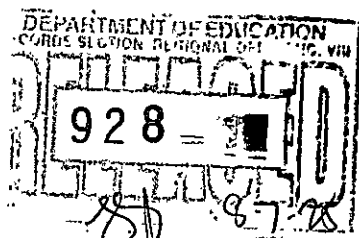

CLOSURE OF THE BASIC EDUCATION PROGRAMS OF COLEGIO DE SAN LORENZO RUIZ DE MANILA OF NORTHERN SAMAR, INC., (SCHOOL ID. NO. 405754), CATARMAN, NORTHERN SAMAR

1. The Department of Education, Regional Office No. VIII, through its Quality Assurance Division (QAD), announces the **CLOSURE** of the Basic Education Programs of **COLEGIO DE SAN LORENZO RUIZ DE MANILA OF NORTHERN SAMAR, INC.**, located at Cor. Balite-Quezon Sts., Brgy. Calachuchi, Catarman, Northern Samar, Region VIII. The school, with **ID No. 405754**, holds **Government Recognition Nos. 01, s. 1993 (Kindergarten); 51, s. 1995 (Elementary); 05, s. 2006 (Junior High School); and Government Permit No. 82, s. 2015 (Senior High School)**. This closure is effective SY 2025-2026.
2. The closure of the school is due to the voluntary withdrawal of Government Recognition under Section 43 of DepEd Order No. 88, s. 2010. This was communicated by Mrs. Leonora M. Adlawan, School Principal, and Dr. Gaudencio C. Aljibe Jr., Ph.D., CESO VI, Schools Division Superintendent, Northern Samar Division, citing the school's financial difficulties in operations following the discontinuation of its tertiary education programs.
3. The Schools Division Superintendent is hereby empowered to facilitate the safekeeping and repository/archive of all the pertinent documents following the guidelines stated in DepEd Order No. 88, s. 2010, Section 154, Custody of Student Records.
4. Immediate dissemination of and strict compliance with this Memorandum are desired.

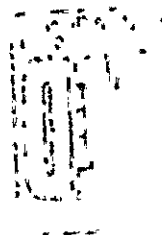

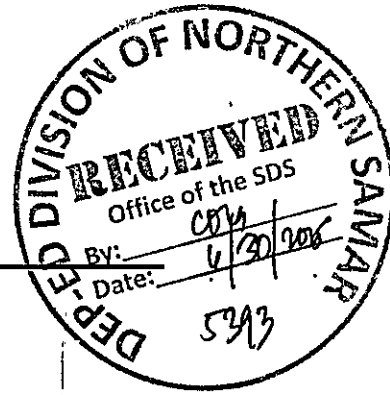

Board Resolution No. 29-25

Be it resolved as it is hereby resolved that the Board of Trustees of Colegio de San Lorenzo Ruiz de Manila of Northern Samar, Inc. Approved the discontinuation of enrollment for ALL the program offerings immediately. The decision comes of the recent outcome from the Commission on Higher Education (CHED) to close the 3 programs, namely: BS Administration, BS Criminology & BS Nursing. In which the board finds that, with the closure of the said programs, the school cannot sustain its operation with only BEEEd and Basic Education.

Now, therefore, it has been unanimously agreed this 5th day of June 2025, by the board that the said resolution be applied effective immediately.
