- 1. Expenses incurred relative to the conduct of the monitoring activity, including travel and other operational costs, shall be charged against RO funds for Regional Office monitors, Division Office local funds for division monitors, and Maintenance and Other Operating Expenses (MOOE) for school-level expenses
