**PLANNING CONFERENCE FOR THE CONDUCT OF THE 2026 EASTERN
VISAYAS REGIONAL ATHLETIC (EVRAA) MEET**

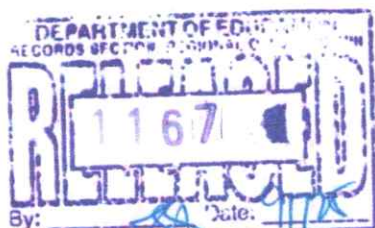
To: Schools Division Superintendents
All Others Concerned

1. This Office, through the Education Support Services Division (ESSD) in coordination with Baybay City Division as the host, shall conduct the **Planning Conference for the Conduct of the 2026 Eastern Visayas Regional Athletic (EVRAA) Meet on October 16-18, 2025, in Baybay City**. The Specific Venue will be announced in a separate memorandum.
2. This activity aims to discuss the preparation of the 2026 EVRAA Meet, specifically on the following:
 - a) gather Division Sports Officers, Regional Tournament Directors, Sports Focal Persons, and DRRM Coordinators;
 - b) define the role and responsibilities of all stakeholders;
 - c) integrate logistics, resource, and safety planning;
 - d) coordinate strategies for sports management and tournament operations; and
 - e) agree on a common action plan for the successful organization of the 2026 EVRAA Meet.
3. Attached is Enclosure No. 1 (List of participants).
4. This is consistent with the rulings under DepEd Order No. 67, s. 1988 and CSC Memorandum Circular No. 9, s. 1988 stipulating that those who travel or render services on days that fall on holidays, weekends, and summer breaks shall also be entitled to avail of service credits or CTO equivalent to eight (8) hours of service per day, whichever is available.
5. CoS and JO are entitled to compensatory overtime credit or overtime pay pursuant to COA and DBM released Joint Circular No. 1, s. 2022 (Policies on the Adoption of Flexible Work Arrangements for Contract of Service [COS] and Job Order [JO] Workers in Government) and as provided for in their respective Service Agreement/s or Contracts. DepEd officials and employees may apply to any flexible work arrangement, endorsed/recommended by their respective heads

6. The participants in this training program shall be provided with meals and accommodation for two (2) days. Travelling expenses, meals, and snacks of the participants shall be charged to local funds/MOOE, subject to the usual accounting and auditing rules and regulations.
