PROCUREMENT FOR THE LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE PARTICIPANTS AND THE MEMBERS OF THE PMT OF THE REGIONAL CAPACITY-BUILDING SEMINAR ON INCLUSIVE EDUCATION INTEGRATION IN THE STRENGTHENED SENIOR HIGH SCHOOL PROGRAM

1. The Department of Education Regional Office VIII, through the **General Appropriations Act CY 2025** intends to apply the sum of **Five Million Six Hundred Thirty-Four Thousand Pesos Only (P5,634,000.00)**, being the **Approved Budget for the Contract (ABC)** for the **PROCUREMENT FOR THE LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE PARTICIPANTS AND THE MEMBERS OF THE PMT OF THE REGIONAL CAPACITY-BUILDING SEMINAR ON INCLUSIVE EDUCATION INTEGRATION IN THE STRENGTHENED SENIOR HIGH SCHOOL PROGRAM**. Bids received in excess of the ABC shall automatically be rejected in accordance with Sec. 31.1 of the Revised IRR of RA 9184 at bid opening.

Training Venue Requirements

1. Big Plenary Hall with sufficient space to accommodate the 313 pax.
2. Presidential table.
3. Has the number of chairs with cover that can accommodate the required participants.
4. Has 6 projector screens: for 6 Breakout Rooms
5. Has an internet speed of at least 1mbps per 145 users.
6. Has 1 speaker system in the plenary hall and to each of the 6 breakout rooms
7. Has at least 2 wireless microphones per session hall.
8. Clean comfort rooms.
9. 1 pc. 1m x 3m tarpaulin to be hung at the plenary hall and another 6 pcs. 1m x 3m tarpaulin for each of the 6 breakout rooms sharing allowed
10. With parking space that can accommodate at least ten (10) 4-wheeled vehicles
11. 3-4 Pax per room; no bed sharing

The Department of Education, Regional Office VIII now invites bids for the **PROCUREMENT FOR THE LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE PARTICIPANTS AND THE MEMBERS OF THE PMT OF THE REGIONAL CAPACITY-BUILDING SEMINAR ON INCLUSIVE EDUCATION INTEGRATION IN THE STRENGTHENED SENIOR HIGH SCHOOL PROGRAM**. Bidders should have completed, within the last Five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the Department of Education Regional Office VIII and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

5. A complete set of **Bidding Documents may be acquired by the interested bidders on the day it is published in PhilGEPS**, in DepEd Regional Office No. VIII, BAC Secretariat, located at Government Center, Candahug, Palo, Leyte, and DepEd Regional Office No. VIII website, **region8.deped.gov.ph**, and upon payment of the applicable fee for **Bidding Documents** amounting to **TEN THOUSAND PESOS (Php 10,000.00)**, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person to **the DepEd Regional Office No. VIII Cashier**.

The Bidder shall submit the duly signed Bidding Documents during the Opening of Bids.

Bidding Documents may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided Bidders shall pay the non-refundable fee for the Bidding Documents.

6. The Department of Education, Regional Office VIII will hold a **Pre-Bid Conference** on **October 15, 2025, 10:00 AM** at the **DepEd Regional Office VIII, Candahug, Palo, Leyte**, through video conferencing via **MICROSOFT TEAMS**, which shall be open to prospective bidders. Physical appearance is also allowed.

7. **Bids must be received by the BAC Secretariat, DepEd Regional Office VIII, Candahug, Palo, Leyte 6501** either through manual/physical submission or through courier **on or before 10:00 a.m. of October 28, 2025**. Late Bids shall not be accepted.

8. **All bids must be accompanied by a Bid Securing Declaration, or any form of Bid Security** and amount indicated in ITB Clause 14.

9. **Bid opening** shall be on **October 28, 2025, 10:15 AM** at the **DepEd Regional Office VIII, Candahug, Palo, Leyte**.

10. Participants are informed that the **Pre-Bid Conference and Opening of Bids shall be broadcasted**/shared to prospective bidders who wish to attend the said procurement activities online, **via Microsoft Teams**. Hence, **interested bidders shall provide** the BAC Secretariat (bac.region8@deped.gov.ph) **their respective Gmail addresses at least one (1) day before, so that they can join the procurement videoconference(s)**. Physical appearance is also allowed.
