PLANNING CONFERENCE WITH REGIONAL AND SCHOOLS DIVISION BUDGET OFFICERS ON THE PREPARATION AND SUBMISSION OF FY 2026 BUDGET EXECUTION DOCUMENTS (BEDs)

- 1. This Office, through the Finance Division, announces the conduct of a Planning Conference with Regional Office and Schools Division Offices (SDOs) Budget Officers on November 5-6, 2025 at the RELC NEAP Region VIII, Government Center, Candahug, Palo, Leyte.

 - b. Preparation and submission of the FY 2026 BED No. 3 (Monthly Disbursement Program); and
 - c. Discussion of other emerging budgetary issues and concerns.
- 3. The participants in this conference shall be the following:
 - a. Schools Division Office (SDO) Budget Officer
 - One (1) SDO Staff who is directly involved in the preparation and encoding of the BEDs (preferably ADAS II/III from the Budget Section);
 and
 - c. Relevant personnel from the Regional Office Finance Division.
- 4. All Participants are required to bring the following essential materials:
 - a. Laptop and extension cord
 - b. Pocket Wi-fi or Mobile Broadband
 - c. Soft and Hard Copies of the FY 2026 National Expenditure Program (NEP)
 - d. Copies of the Financial Accountability Report (FAR) No. 1 as of September 30, 2025; and
 - e. Official report on the Status of Allotment Utilization as of October 31, 2025
