Bid proposals received in excess of the ABC shall be automatically rejected in accordance with Sec. 31.1 of the Revised IRR of RA 9184.



- 2. The Department of Education Regional Office VIII through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers to participate in this procurement.
- **3.** The procurement procedure for this requirement is Negotiated Procurement pursuant to Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act". The BAC will engage in negotiations with sufficient a number of suppliers to ensure effective competition. The selection of the successful offer shall be based on the best and final offer that will be submitted on the specified date below and meets the minimum technical specifications.
