**CONDUCT OF FOURTH QUARTER REGION AND DIVISION OFFICE DISASTER RISK  
REDUCTION AND MANAGEMENT (DRRM) CONFERENCE**

1. In line with the Department of Education's (DepEd) commitment to ensuring the safety and well-being of learners and school communities, this Office informs all Division DRRM Coordinators on the conduct of the Fourth Quarter Region and Division Office Disaster Risk Reduction and Management (DRRM) Conference which will be held at Calbayog City on **November 25-28, 2025**. The specific venue will be announced in another memorandum after the procurement process.
2. The activity shall be participated by the following: four (4) representatives from the Education Support Services Division, thirteen (13) SGOD Chief, thirteen (13) Division DRRM Coordinators, Ten (10) Division DRRM Administrative Support Staff and three (3) personnel from the host Divisions as part of the Technical Working Group (TWG).
3. The activity aims to review and assess the implementation of DRRM PPAs at the region and division levels, discuss concerns on FY 2025 Disaster Preparedness and Response Program (DPRP) Current and Continuing Funds, and discuss upcoming DRRM related activities.
4. The transportation expenses and per diem of the participants shall be charged against their respective DPRP Fund/Maintenance and Other Operating Expenses (MOOE), subject to the existing accounting and auditing rules and regulations.
5. Immediate dissemination of and compliance with this Memorandum are desired.
