## UPDATES ON THE CONDUCT OF CAPACITY-BUILDING SEMINAR ON INCLUSIVE EDUCATION INTEGRATION IN THE STRENGTHENED SENIOR HIGH SCHOOL PROGRAM

To: Schools Division Superintendents
All Others Concerned

- 1. This Office, through the Curriculum and Learning Management Division (CLMD), announces updates regarding the conduct of the Capacity-Building Seminar on Inclusive Education Integration in the Strengthened Senior High School Program:
  - a. The seminar schedule has been adjusted due to unforeseen circumstances brought about by Typhoon Tino. The revised schedule is indicated below:

- d. Travel expenses of Education Program Supervisors, participants from schools implementing the Special Needs Education Program, including the shall be charged to their respective Division SNED Program Support Fund and School SNED Program Support Fund. For non-SNED implementing schools, reimbursement of travel expenses shall follow the provisions of RM No. 1036, s. 2025, subject to the usual government accounting rules and regulations.
