- 1. 

Annex A

Guidelines for the Selection of Participants for the Regional Environmental Convention

I. Eligibility

The participants must be bonafide students of any public or private school, enrolled in their respective year levels.

II. Selection

- a. The Bureau shall receive the final list of recommended participants from the Department of Education Region 8, 50 Students and 20 Teachers from Schools in Divisions selected according to the discretion of DepEd.
- b. The Bureau reserves the authority of selection to the discretion of the Regional Office.
- c. The participating students may consist of students from the same, or from separate grade levels in **Junior or Senior High Schools**

III. Convention Proper

- a. The Bureau shall provide the updates and reminders for the participants. The decision of the Board consisting of EMB RO8 and partner representatives shall be upheld.
- b. The Bureau, as the organizing committee, shall be responsible for the Food, Venue, and Materials requirements for the Convention.



Annex B

Request for Participation of EMB Environmental Education and Information Unit in a Management Conference of DepEd

I. Rationale

Among the programs of the DENR – EMB is the National Search for Sustainable and Eco-friendly Schools (NSSEFS) that recognizes schools in primary, secondary, and tertiary levels for their environmentally sound and sustainable programs. With this, we are enjoined to train and partner with teachers and school heads in its implementation.

II. Status Quo

The 2024 NSSEFS validation is ongoing this year. The 2024 NSSEFS is set to award the schools that provided the necessary Means of Verification and have existing programs within 2021-2024, the three-year period covered by the NSSEFS in the interest of sustainability of programs. The next NSSEFS validation should be on 2027 which will check the programs kickstarted within 2024 until 2027.

III. Request

The Bureau has conducted trainings with schools and last year, with the Schools Division of Leyte. We wish to reach more teachers to introduce the NSSEFS to a larger scope this year. With this, we are respectfully requesting to be allowed to present the NSSEFS Program in one of the Management Conferences of DepED that gather educators from all over the Region.
