- 2. All assigned Risk Management Team (RMT) members responsible for monitoring and reviewing the risk management cycle must adhere strictly to the established procedures for the Quarterly Risk Management Cycle, including the following:
 - a. Recommendations provided by each designated monitor in each functional division **must be in handwritten**.
 - b. The following forms must be utilized:
 - · Risk and Opportunity Monitoring Review Form.
 - Risk and Opportunity Registry Monitoring Checklist for the Fourth Quarter.
 - c. Ensure that all required information is completed in the checklist (e.g., date monitored, functional division monitored).
- 3. Upon completing the quarterly monitoring and review, the Risk Management Team is required to submit the Risk Monitoring and Review Form and the Risk and Opportunity Registry Monitoring Checklist to **Ms. Alma E. Suyom**, the RMT Chair.
